### Navigational Exercise (Navex) Friday 20th Feb 2026

1. Sixty & Worcestershire Motor Club will organise a Navigational Exercise on Friday 20<sup>th</sup> Feb '26
  2. The event will be governed by the General Regulations of Motorsport UK (incorporating the provisions of the Sporting Code of the FIA), by these supplementary Regulations and any written instructions that the organising club may issue for this event.
  3. Motorsport UK Certificate of Exemption has been applied for.
  4. The event is open to members of the organising club and anyone else. It is not a requirement to be a club member or for participants to hold a competition licence.
  5. Entries open with the publication of these regulations and will be accepted in order of receipt. Entries will be limited to 12 cars.
  6. The entry fee is £10-00 per car. Payable by BACS to Lloyds Bank 30-97-77, 23335268 or PayPal to [sales@sixtyworcsmc.co.uk](mailto:sales@sixtyworcsmc.co.uk), Please include the event name and your name within the payment detail.
  7. Entries cancelled prior to the closing date will receive full refunds, after that date and more than 24 hrs before the start of the event the organisers *may* issue a partial refund.

10. The start will be :- The Camp House Inn, WR2 6LX Map Ref: 834/591
  11. The finish will be :- The Camp House Inn, WR2 6LX
  12. O.S. map 150 will be required.
  13. Instructions will be; Map Ref / Tulip Diagrams / Spot Height / Black Spot / Code Boards.
  14. The route will be timed at 10 mph. Anyone arriving at the finish after 21-30 will be penalised.
  15. There will be two classes Experts and Novices  
Experts are a crew where any member has finished in the top five of ANY Rally or Navex in the last 10 years in any capacity.  
Novices will be all others. Novices will receive help marking their maps to the correct route.
  16. All crews will receive their route instructions at the same time
  17. All vehicles must be road legal and be taxed and insured.
  18. Question and answer cards will be provided, and Points will be awarded as follows:
    - 10 Points for every correct answer
    - 0 Points for every missed answer
    - -10 Points for every Incorrect answer
    - - 1 Point per minute arriving at the finish after 21-30
    - Exclusion arriving at the finish after 22-00
  19. The winner will be the crew with the Most Points
  20. Ties will be decided by furthest cleanest and then by a deciding question at the end of the route card.  
If a tie still exists, then it will remain a tie.
  21. Results will be announced as soon as possible at the end of the event and will be sent out to competitors by e-mail on Saturday 21<sup>st</sup> Feb.
  22. In the spirit of the event, **protests will not be accepted.**
  23. Competitors and officials are asked to consider the environment that this event operates in and ensure that noise is not excessive. Competitors are encouraged to carry a spill kit in order to limit contamination to the course in the event of oil or water spillage.
